DECISION

Both parties are absent.

Upon perusal of the entire case records in the file, it has been found that the present Appellant has sought information on two queries regarding the (i) file notings and its correspondences related with the process for issuance of Order No. DISC-1/3/2023-DP-DP dated 22.8.2023 issued by DP & AR, Government of Manipur, (for placing the suspension of the Appellant), and the (ii) file notings and its correspondences in connection with the process for issuance of Order No. DISC-1/3/2023-DP-DP dated 8.8.2023 and its subsequent extension period of suspension from 15.8.2024 to 10.2.2025 issued by DP & AR, Government of Manipur.

The Commission received a letter dated 11.2.2025 from the DP, Government of Manipur. The Public Authority vide this letter prayed that the present Appeal case is related with earlier Appeal case No. 67 of 2024 as it pertains to the transfer, posting, suspension and its extension of suspension of the present Appellant. It also stated that the Commission has upheld the decision of the DP, Government of Manipur dated 20.9.2024, as the decision of the DP, Government of Manipur was taken in consideration with the sensitive and fragile ethnic strife prevailing in Jiribam District under Section 8(1) (a) of the RTI Act, and accordingly it requested the Commission to pass an order as done in the appeal case 67 of 2024.

Observation: -

The Commission is of the opinion that the present Appeal case is co-related with earlier Appeal case No. 67 of 2024 in which the Commission has upheld the decision of the SPIO/ DP, Government of Manipur. Similarly, the Commission further upholds the letter/ decision of the DP, Government of Manipur dated 11.2.2025. Hence, there is no need for further intervention in the present Appeal proceedings.

Accordingly, the Appeal case is closed on ex-parte.
