## DECISION

Md. Gayasuddin Khan, SDO/ BDO, Khengjoy, Chandel appears in person. The Appellant is present.

The Commission is of the opinion that once the information is available/ accessible for general public by accessing the said web link provided by the Public Authority, there is no need for further intervention in the present proceedings as the sought information are already available in public domain.
